III.B. REPORTS

1. **Follow-up report on the Whole School Inspection of the European School of Bergen (2020-01-D-42-en-1)**

Following the Whole School Inspection carried out in November 2017, the Bergen School had produced comprehensive and very clear plans for implementation of the recommendations. The School was, however, invited to evaluate the progress made and include it in the School's annual pedagogical plan.

The Joint Board of Inspectors approved the follow-up report on the Whole School Inspection of the European School of Bergen.

2. **Follow-up report on the Whole School Inspection of the European School of Brussels II (2020-01-D-43-en-1)**

The Working Group and the 'Whole School Inspections' Steering Group reported on the failure to follow up on the recommendations and on their lack of means to put into effect the regulations on Whole School Inspection in such a situation. Consequently, the JBI decided to reactivate the 'Revision of the profile of Directors and Deputy Directors' Working Group in order to work on their profile and to incorporate into it the follow-up on the recommendations of the Whole School Inspection for which they were responsible.
