### **III. ITEMS**

#### **III.A. SYLLABUSES**

##### **1. Attainment Descriptors for Economics S4-S5 – 2021-09-D-16-en-1 – M-J BUGIA**

The B.I.S approved the Attainment Descriptors for Economics in S4-S5. They would be incorporated into the syllabus and would enter into force immediately for S4 and on 1 September 2022 for S5. They would be sent forward to the JTC and to the BoG for their information.

#### **New syllabuses**

##### **1. Organisational arrangements for written examinations and B tests for the new Mathematics syllabuses S5-S7 from 2021-2022 School Year – 2021-09-D-49-en-1 – A. YILMAZ**

The B.I.S approved the document on the 'Organisational arrangements for written examinations and B tests for the new Mathematics syllabuses S5-S7 from 2021-2022 School Year'. Entry into force was immediate and the document cancelled and replaced document 2010-D-441-en-5. The document would be sent forward to the JTC and to the BoG for their information.

##### **2. Modification of the sample paper of Written BAC examination as part of History S6/S7 – 2013-01-D-35-en-7 – R. JURANOVA**

The B.I.S approved modification of the sample paper of the Written BAC examination as part of the History S6/S7 syllabus. The modification would enter into force immediately. The adapted syllabus would be published on the website. It would be sent forward to the JTC and to the BoG for their information.

##### **9. European Schools' Criteria for the Assessment of the 2022 BaccaLaureate Oral Exams – 2021-01-D-3-en-4 – L. DAMKJAER**
